

SCDC MINIMUM AND FEMALE SECURITY INSTITUTIONS WITH CONTACT VISITATION
IN-PERSON VISITATION PROCEDURES

Phase 6.1 - In-Person Visitation Procedures at Manning Reentry & Work Release Center, Goodman CI, Palmer Pre-Release Center, Livesay CI, Leath CI, Camille CI, and Wateree CI

I. Eligibility

All inmates without visitation restrictions are eligible for two in-person visits per week (every seven days) and a maximum of eight in-person visits per month.

II. Scheduling

A. In-Person visitation is scheduled on Saturdays and Sundays during the following times:

8:00 am to 10:00 am
11:00 am to 1:00 pm
2:00 pm to 4:00 pm

- B. Each visit will be no longer than two hours in length.
- C. Up to four visitors (one must be an adult) may visit an inmate during a visitation period. Children of all ages may visit; however, they must be approved and on the inmate’s visitation list.
- D. Only approved visitors can schedule a visit (must be on the inmate’s visitation list).
- E. Visits are by appointment and must be scheduled following the link below:

- F. Visitors should arrive no more than 30 minutes prior to the scheduled visitation time.
- G. Visitation is limited at each institution during each visitation session based on social distancing for tables.
 - i. No more than 24 visits at Livesay CI A and 24 visits at Livesay B.
 - ii. No more than 18 visits at Leath CI and Camille CI.
 - iii. No more than 12 visits at Goodman CI, Palmer Pre-Release Center, Manning Reentry & Work Release Center, and Wateree CI.

III. COVID-19 Protocols

- A. Social Distancing shall be adhered to except for an embrace at entry and exit will be permitted.
- B. Visitors are not required to show proof of vaccination nor show results of a negative COVID test.
- C. All visitors will be screened for signs and symptoms of COVID-19 utilizing an SCDC questionnaire.
- D. All visitors will have their temperature checked.
- E. Visitors who do not clear the questionnaire will not be allowed to visit.
- F. Visitors with a temperate of 100.0 degrees or greater will not be allowed to visit.
- G. Visitors displaying any signs or symptoms of COVID-19 will not be allowed to visit.
- H. Wearing of surgical masks:
 - i. For institutions on “Everyday” COVID Operations status, surgical masks (issued by the institution) are encouraged to be worn by all visitors.
 - ii. For institutions on “Enhanced” COVID Operations status, all visitors ages four (4) and older will be required to wear a surgical mask (issued by the institution) during the entirety of the visit.
- I. Inmates will be screened for signs and symptoms of COVID-19 utilizing standardized inmate screening questions.

- J. Inmates will have their temperature checked.
- K. Inmates who do not clear the screening will not be allowed to visit.
- L. Inmates with a temperature of 100.0 or greater will not be allowed to visit.
- M. Staff shall wear proper PPE in accordance with the COVID Operations status – Everyday or Enhanced.
- N. Staff screening visitors will exchange gloves and hand sanitize between each search of a visitor.
- O. Housing units or living areas under quarantine will have visitation canceled.
- P. Visitation may be conducted inside and/or outside (if available and at the Warden’s discretion). Inclement weather may result in the cancelation of any approved outside visitation.
- Q. Vending machines will be accessible. Once purchased and opened, food or drink will not be shared between visitors and inmates.
- R. Restrooms located outside of the institution or in the lobby may be available (processing area). Visitors are encouraged to utilize restrooms prior to arriving at the institution.
- S. IRC photos may be taken at a location approved by the Warden in accordance with PS-10.03 “Inmate Representative Committees”.
- T. Visitation tables and chairs will be sanitized prior to use, between each visitation period, and at the end of the day.

IV. Rules for Visitors

- A. The rules of conduct and dress code outlined in the SCDC Visitation Policy apply to all in-person visits.
- B. Surgical masks shall be worn as indicated in Section III.H. above.
- C. Restrooms located in the visitation area will be accessible for visitors for a one-time use during the scheduled visitation period. Minor children (9 years of age and younger) must accompany visitors to the restroom and shall serve as both visitor’s one-time usage.
- D. Visitors are requested to immediately inform the institution if they receive a diagnosis or develop signs or symptoms of COVID-19 within 48 hours after a visit.

V. Rules for Inmates

- A. All inmate rules and regulations for visitation, as stated in the Visitation Policy apply to all in-person visits.
- B. Wearing of surgical masks:
 - i. For institutions on “Everyday” COVID Operations status, surgical masks (issued by the institution) are encouraged to be worn by all inmates.
 - ii. For institutions on “Enhanced” COVID Operations status, all inmates will be required to wear a surgical mask (issued by the institution) during the entirety of the visit.
- C. Inmates requesting to utilize the restroom will be returned to their housing unit/living area and the visitation period will be canceled. However, the Duty Warden may allow an inmate with a documented, qualified disability to return to visitation after a restroom break, circumstances permitting.

VI. Supervision of Visits

- A. Visitation staff shall wear proper PPE in accordance with the COVID Operations status – Everyday or Enhanced.
- B. Visitors will be asked to exit the visitation area and maintain social distance (6 ft).
- C. Visitation chairs and tables will be sanitized between each use.
- D. Vending machines will be sanitized between each use.
